What is FIREWISE?

Firewise USA is administered by the National Fire Protection Association (NFPA). It recognizes communities that have met specific criteria for wildfire risk mitigation.

The program aims to motivate neighborhoods to undertake wildfire mitigation in their community, while also being prepared for wildfire.

WEED CONTROL, SPRING WORK

By mid-April, noxious weeds will begin appearing in our open space. These non-native plants harm our environment and Colorado law requires their control.

Weed Wranglers will spray in mid-April to control Hoary Cress before flowers emerge.
